The meeting opened with the Lord's Prayer. The minutes from the June 12, 2017 meeting were read and approved.

None of the Trustees had any new ideas for board replacement. Isaac Bailey moved to table the board replacement, and Mark Bushman seconded the motion. All were in favor.

Jim Cajka asked about the grant for big trucks, and if Webster Township had a chance of getting it. Isaac Bailey will look into it.

There was nothing to report on pipelines, the Webster School property, or the catch basin work.

The Trustees then reviewed the quotes from the County to chip seal Stony Ridge, Dunipace, and Devils Hole Roads. They also looked over the quotes from Whitta Construction to pave with cold mix Aufderstrasse Road and Anderson Road between Nelson and Sugar Ridge Roads which would potentially be split with Center Township. Whitta Construction provided two quotes for each job with different thicknesses. The County also provided some prices from roads they recently striped, and the Trustees discussed areas where striping may work. Isaac Bailey made a motion to table the road work until the Trustees can look over the bids. Mark Bushman seconded the motion and all were in favor.

Julie Foos brought up the Township's desktop computer. The Auditor of State' office provided a laptop for the Fiscal Officer to use and donated the desktop to the Township to do whatever with. Isaac Bailey made a motion to let Dave Welling use the old computer. Mark Bushman seconded the motion and all were in favor.

Dave Welling gave a report on zoning. He has issued nine permits so far this year and recently did an audit. He found a few minor issues he will check into further.

Isaac Bailey turned the discussion to the damage done at the Old Belleville Ridge Cemetery from a recent storm. Some of the trees split and knocked a few headstones off their base. Randy Aspacher and Joe Kirkman will work on cleaning up the mess.

Randy Aspacher reported that he had cut the stumps down from the trees that were removed on Main Road. He will start mowing again in the coming week.
