The meeting opened with the Lord's Prayer. The minutes from the May 28, 2019 meeting were read and approved.

The Trustees began with old business. Anderson Road has not been fixed yet because of the weather. Jim Cajka has not heard anything about getting grindings from the State Route 582 project. No one has gotten any quotes from the County about road improvements. Mark has not heard from the State about the corner of Silverwood Road and State Route 105. It is still too muddy to do anything about the Webster Cemetery driveway.

Julie Foos is going to meet with the Wood Count Chapter of the Ohio Genealogical Society in the next week about the cemetery maps.

Isaac Bailey will spray the Webster School property as soon as the weather cooperates. Randy Aspacher removed the plastic border around the playground. Julie Foos had no update on the potential easement.

Isaac Bailey tried to remove the trees, but it rained again.

Mark Bushman was advised that many people do not stop at the stop sign on the corner of Anderson Road and Devils Hole Road. Mark Bushman will call the Sheriff's Department and see if they can patrol the area.

Julie Foos reported Center Township has not come up with a service area for fire protection, so she will send over Webster Township's recommendation. Isaac Bailey made a motion to accept a service area east to Silverwood Road from the Center Township line to Sugar Ridge Road. Mark Bushman seconded the motion and all were in favor.

Jim Cajka has been in touch with Shad Ridenour about the sale of the Devils Hole Road property and will try to get some more concrete answers.

Julie Foos talked to Ken Gahler about the new tractor and learned that Case IH does not use the state cooperative purchasing program, but uses a similar program. Julie Foos has applied to the program and is waiting to hear back. Jim Cajka will see when the equipment will be available.

Randy Aspacher reported he mowed all of the roadsides once.

Julie Foos mentioned the state auditor indicated the audit was wrapping up.

Randy Aspacher believes the township would be better off buying forks and a quick hitch for the new tractor online rather than from the dealer.

The Trustees began discussing new business. Isaac Bailey said some trees fell down on Chamberlain Road, but he cut them up and got them off the road.




