The meeting opened with the Lord's Prayer. The minutes from the June 10, 2019 meeting were read and approved. The Fiscal Officer's report was also approved.

The meeting began with old business. Julie Foos reported the audit is still ongoing, but she expects to hear the results any day.

The Trustees discussed the roads. The township has not gotten any grindings from the State Route 582 project, so Anderson Road has not been fixed. Isaac Bailey is working with the County to adjust the haul route for the project. Isaac Bailey has gotten several complaints about the intersections of Devils Hole Road and Anderson Road as well as Anderson Road and State Route 582. Mark Bushman still has not heard from the State about Silverwood Road or from the County about the quotes for road improvements. Jim Cajka was contacted by Unilliance about getting quotes for road improvements and will provide them with a list.

Yardwork and Snow Removal, LLC removed the tree on the corner of Anderson Road and Devils Hole Road and will provide a quote to remove the trees on Dowling Road.

Julie Foos reported she sent Center Township the Trustees' recommendations for coverage area but has not heard back.

The Devils Hole Road property was discussed next. Jim Cajka spoke with Shad Ridenour who is willing to be present for the sale. The Trustees agreed to sell the property by sealed bid on September 23 at 7:00 P.M at the township hall. Jim Cajka moved to accept Resolution 19-004, A Resolution for the Sale of Real Property Which is No Longer Needed for Public Use, is Obsolete, or is Unfit for the Use for Which it was Acquired and Isaac Bailey seconded. All were in favor in a roll call vote. The Trustees and Julie Foos reviewed the bid form and the sale notices to be posted on the website, on Facebook, and in the Sentinel.

Jim Cajka reported the new tractor should be delivered on Tuesday after the dealer moves the weights to the other side. The Trustees and Randy Aspacher discussed the logistics of getting the old tractor back to the dealer.

Julie Foos relayed what she learned from the Wood County Chapter of the Ohio Genealogical Society. The chapter provided a map of the Old Belleville Ridge Cemetery and a listing of all the burials in the Webster Cemetery up to 1992. Mark Bushman suggested Julie Foos have the website administrator post the current maps of both cemeteries on the website.

The meeting turned to old business. Randy Aspacher put new paper towel dispensers in the bathrooms and got more supplies for the hall.
