

**GRAND RAPIDS TOWNSHIP REGULAR MEETING**

July 27, 2020

The Grand Rapids Township Trustees met at 7:00 P.M. in the Grand Rapids Township Fire Hall. Ike Topp, David Chamberlain and Rita Foos answered roll call. There were five guests.

Rita Foos moved to approve and dispense with the reading of the minutes, as copies were available to guests. 2<sup>nd</sup> by Ike Topp. Roll Call YES: Ike Topp, David Chamberlain and Rita Foos. Motion carried.

The Fiscal Officer presented bills in the amount of \$9,032.91 for approval. Rita Foos moved to pay all bills as presented. 2<sup>nd</sup> by David Chamberlain. Roll Call YES: David Chamberlain, Ike Topp and Rita Foos. Motion carried.

Zoning Inspector Brad Trumbull reported that he recently issued two building permits.

Rita Foos said that Beaver Creek Road has been surface treated and that the contractor is going to return to do the approaches and repair damage caused by traffic.

David Chamberlain stated that he has been in touch with Matt Kubacki and was informed by Matt that he has been very busy and is trying to get the tuck-pointing for the mausoleum scheduled.

Rita Foos moved to appoint McKenzie Keim to finish the vacant term expiring December 31, 2020. 2<sup>nd</sup> by Ike Topp. Roll Call YES: Ike Topp, David Chamberlain and Rita Foos. Motion carried.

Loren Sautter asked why he has not been appointed to the Board of Appeals. Rita Foos said that McKenzie was an alternate before Loren was.

Dave Chamberlain informed the board that Mike Plotts is going to be pouring footers in the next couple of weeks.

Rita Foos said that she was contacted by Weston Township and informed that they would like to widen Weston Road from Route 6 to Poe Road and wanted to know if we would pay for our portion of the road. It was decided to wait for project estimates before a decision is made.

Rita Foos said that she called around for propane prices and received prices ranging from \$.89 to \$1.59 per gallon. David Chamberlain moved to have Napoleon Propane fill the tank for \$.89 a gallon. 2<sup>nd</sup> by Ike Topp. Roll Call YES: David Chamberlain, Ike Topp and Rita Foos. Motion carried.

Loren Sautter spoke up and said that he wanted an explanation on why two people have been appointed to the Board of Appeals before him. Rita Foos stated that she did not have a reason. Loren asked why she was avoiding the question.
